## What is this product?

### TYPE OF PRODUCT

The product is a sub-fund of Alessia, an Undertaking for Collective Investment in Transferable Securities (UCITS) incorporated as a variable capital investment company (SICAV) under the laws of Luxembourg.

#### IERM

The Fund is established for an unlimited duration. However the Board of Directors of the Fund may decide to close the Fund under certain circumstances.

#### **OBJECTIVES**

The sub-fund seeks positive return with relative low volatility and limited correlation to market cycles affecting traditional equity and fixed income markets.

#### Investment policy

The sub-fund is actively managed and is not managed in reference to a benchmark.

The sub-fund invests in equity markets, fixed income, corporate bonds, foreign exchange and related financial derivative instruments. In order to achieve its objectives, the sub-fund bases its investment decisions on detailed analysis and research. The aim of the research is to look for unbalances in interest rates, equity values, foreign exchange rates and credit prices that could be adjusted in the future.

Cash is mainly invested in a diversified basket of equities and/or a basket of bonds and money market instruments.

Derivative financial instruments are used both for hedging reasons and to enhance portfolio return creating long and/or short exposures to various asset classes (equity, fixed income, currency, credit) and markets. The sub-fund will mainly use exchange traded derivatives. In order to enhance portfolio performance short term trading activities will be added to the normal asset allocation process.

The investor may subscribe, convert and redeem shares on each bank business day in Luxembourg.

These shares are capitalisation shares. Income and capital gains are reinvested.

### INTENDED RETAIL INVESTORS

The product is reserved for professional investors with good knowledge of the underlying financial instruments and good financial industry experience. The product is compatible with investors who may bear capital losses and who do not need capital guarantee. The product is compatible with clients looking for growing their capital and who wish to hold their investment over 4 years.



# What are the risks and what could I get in return?

# What happens if PURE CAPITAL S.A. is unable to pay out?

# What are the costs?

# How long should I hold it and can I take my money out early?

### Recommended Holding Period (RHP): 4 years.

The RHP was chosen to provide a consistent return less dependent on market fluctuations.

Shares in the Sub-Fund may be redeemed as of each Valuation Day. Redemption requests must be sent in writing to the Administrative Agent, or the relevant Distributor or a sub-distributor, if any. Redemption requests must be received by the Administrative Agent not later than 2.00 p.m. (CET) on the relevant Valuation Day. Redemption requests received after this deadline will be processed on the next following Valuation Day.
